1. Purpose of Report (Including link to objectives)

The purpose of the Chief Executive's Report is to highlight key developments within the Trust which have taken place since the last Board meeting.

2. Summary of Key Issues for Discussion

2.1 Care Quality Commission Responsive Visit

The Care Quality Commission (CQC) made an unannounced responsive inspection of the Trust between $4^{th}-6^{th}$ February 2013. This inspection resulted from feedback from the local health community and focused on how the Trust discharged patients. The CQC also reviewed the Trust's use of the Day Surgery Unit as an escalation area, when the hospital was having to deal with unprecedented numbers of emergency patients. At the time of writing this report only verbal feedback had been received from the CQC and the Trust was working closely with the Regulators to address their concerns. Once the inspection report has been finalised this will be presented to the Trust Board.

2.2 Operational Performance

High levels of emergency activity continued during January 2013. Declaration of black escalation for the whole health community between $4-7^{th}$ January did yield some respite to the RUH's operational pressures. However, it quickly became apparent that the spreading of the operational pressures across the health and social community was giving cause for concern in relation to staffing and community capacity. All partners have identified what additional actions can be reasonably taken in order to respond to the immediate to short term challenges. It is unlikely that these actions will be sufficient to return to normal operating capacity and levels of activity within the hospital. As a consequence the 4hour recovery plan is being closely monitored by the weekly taskforce as a means of controlling the risk and ensuring patient safety.

2.3 NHS Litigation Authority Inspection

The Trust was assessed by the NHS Litigation Authority on 12th February 2013 against their Risk Management Standards. The assessment was a follow up to the assessment in February 2012 where the Trust was unsuccessful at level 2.

The Trust achieved NHSLA level 1 compliance in all of the standards. A report on the outcome of the inspection will be presented to the Trust Board in March 2013.
