CHIEF EXECUTIVE'S REPORT

1.1 NHS Long Term Plan

The NHS Long Term Plan was published on 7th January 2019 and sets out the how the £20.5 billion budget settlement for the NHS will be used over the next five years to improve the quality of patient care and outcomes. The plan focuses on building an NHS fit for the future by:

- · enabling everyone to get the best start in life
- helping communities to live well
- helping people to age well

The plan has been developed in partnership with frontline health and care staff, patients and their families. It will improve outcomes for major diseases, including cancer, heart disease, stroke, respiratory disease and dementia. 1.2 100,000 Genomes Project reaches target

The project to sequence the genetic makeup of 100,000 NHS patients reached its target in December 2018. The RUH was part of the West of England Genomic Medicine Centre and contributed more than 4000 whole genome samples taken from consenting patients and family members. The pioneering 100,000 Genomes Project was set up in 2012 with the goal of harnessing whole genome sequencing technology to improve diagnosis and treatment of patients with rare inherited diseases and cancer.

1.3 New X-ray Machine for Cardiac Care

The Catheter Laboratory 1 at the Trust has been refurbished, including the control and equipment rooms, and a new X-ray machine has also been installed. The new X-ray machine provides a far clearer image of the coronary arteries, while its specialist software packages allows staff to see and position coronary stents in far more detail. The machine is one of the newest from GE and will enable the Trust to complete procedures using less radiation, which is beneficial to both patients and staff.

1.4 Modular Ward

A new modular ward arrived on the RUH site in January, marking the start of a major five-year improvement and maintenance project. Work is now underway to fit out and equip the ward internally and to link it to the main hospital by a new corridor, to be ready for use in early 2019. The new ward will, act as a decant ward providing space to allow another 16 wards, one at a time, to move in while upgrading and refurbishment work takes place in the vacated area. The modular ward has a maximum of 27 beds and is built to a very high standard to offer all the facilities found in a modern hospital ward.

1.5 Smokefree site

All RUH sites became smokefree on 1st January 2019. Tobacco smoking is not permitted on site, but vaping is allowed outdoors. Smoking shelters on Trust grounds have been removed. The Trust is providing support for staff to stop smoking completely or help to manage cravings while at work. The Trust also runs the Healthy Choices initiative, which involves screening inpatients where needed, providing advice about smoking and alcohol consumption. If appropriate, the patient is referred for further support. Nicotine replacement therapies like gum and patches are also available for inpatients.
