Purpose

To provide the Council of Governors with an update following the Governor elections in 2017. The 2017 elections took place from 14 August to 25 October 2017 with the aim of electing three Staff Governors, and six Public Governors across all of our public constituencies. This was the second constituency-wide election for new Governors since becoming an NHS Foundation Trust hospital in 2014.

2017 Governor Election

The process to elect new Governors began on 14 August 2017.

The Electoral Reform Services acted as the Trust's Returning Officer, and all election material was distributed and received by them. All eligible members within the following constituencies were eligible to apply:

- City of Bath
- North East Somerset
- Mendip
- North Wiltshire
- South Wiltshire
- Rest of England and Wales
- Staff

Promotion of the Election

During the year there was a campaign of activities to raise public, staff and member awareness of the intention to run the second Constituency wide election since becoming an NHS FT in 2014. Key activities were similar to the year before and included:

• Information guides about becoming a governor were created for sharing with all interested public and staff members.

- Regular contact was made with all members who had expressed an interest.
 These individuals were also invited to meet the Membership & Governance
 Manager and Chairman to find out more about the role.
- The Communications Department supported the entire election process by updating and sending press releases focused to the community areas and also utilising social media platforms.
- The RUH website was regularly updated, include a "Becoming a Governor" button on the front page for members to express interest in standing. This linked into a page about the Council of Governors and further information about the election.
- Nominations and elections were promoted in the member's newsletter and in the Insight and @RUHBath magazines for all members.

The election process followed a longer timetable (55 days) as it spanned the summer months. Below is a summary of the key figures during this process.

- 31 members (and the public) requested the Trust's Public Governor Information booklet.
- 52 members requested a nomination form from the Electoral Reform Services.
- Of those members, **21** returned their nomination forms.
- 2 candidates withdrew their applications, both public members one from South Wiltshire and one from the City of Bath constituency, leaving 19 potential candidates split as follows:
 - o City of Bath 4
 - North East Somerset 4
 - o Mendip 3
 - o North Wiltshire − 2
 - South Wiltshire 1
 - Rest of England and Wales 0
 - Staff 5
- Candidates signed up approximately 85 members to support their election campaigns.
- 7,619 public members were eligible to vote.
- 5,156 staff members were eligible to vote.
- 1,657 / 7,619 public members voted = 21.7% of the public membership
 - Constituency split as follows:
 - City of Bath -598 / 2,519 = 23.7%
 - North East Somerset 452 / 2,014 = **22.4%**
 - Mendip 291 / 1,284 = **22.7%**
 - North Wiltshire 316 / 1,802 = **17.5%**

- Although turnout was down on last year, the results are still good considering
 the number of elections we have had to take part in nationally. ERS confirmed
 that in general, public turnout was usually higher than staff. The majority of
 NHS Foundation Trusts average a 15-20% turnout.
- 718 / 5,156 staff members voted = 13.9% of the staff membership
- Staff voting turnout was still disappointing (but 0.9% up on last year), and ERS commented that in comparison the average staff turnout for all FT elections that ERS run is around 15%
- During the election, 32 members cancelled their Trust membership as a result of the receiving the election material.
- The successful candidates were elected to the RUH's Council of Governors and began their term on 1st November 2017:
 - Amanda Buss City of Bath(re-elected)
 - Helen Rogers North East Somerset (re-elected)
 - Mike Welton Mendip (re-elected)
 - Jacek Kownacki North Wiltshire
- Chris Hardy was confirmed as the new Governor for South Wiltshire and was confirmed through an uncontested election (after the other candidate withdrew prior to the vote).

Rest of England and Wales bi-election

Whilst four members from the Rest of England and Wales constituency expressed an interest, none of the nomination forms were returned to ERS and as a result a bielection is being held.

The bi-election for this constituency began on 26th October, and the election timetable is as follows:
