1. | Executive Summary of the Report

NHS Improvement requires NHS Foundation Trusts to make a number of returns and declarations over the course of the financial year. NHS Improvement requires the Board of Directors to confirm (or otherwise) the following statement by 30 June 2018.

"The Board is satisfied that during the financial year most recently ended the Trust has provided the necessary training to its Governors, as required in \$151(5) of the Health and Social Care Act, to ensure they are equipped with the skills and knowledge they need to undertake their role.

Signed on behalf of the Board of directors, and having regard to the views of the governors."
