Business Undertaken

 - An analysis of the cost of recruitment campaigns against number of members recruited.

Draft Annual Report

The working group was informed that the Membership Team would be pursuing the membership video with the Trust's videographer and agreed to send a letter to the college thanking the students for their contribution to the project.

Review Question for the AGM

The working group approved the suggested question for the AGM and ask the Council of Governors to approve:

Our goal is to be recognised as a listening organisation, patient centred and compassionate.

"What would you suggest we focus on over the next 12 months which would make the most difference to realising this goal"?

Exceptions and Challenges

2018/19 Membership & Engagement Strategy – Update on Progress

The working group discussed the challenge of recruiting younger members and suggested using the College Fresher's Fairs as a way to gather information from the students on what would interest them about becoming a member. They also discussed targeting younger people through social media and the possibility of holding Caring for You events at a college on topics relevant to younger people.

Activity

Each year the working group agrees its work plan. The main focus of activity is on the Public and Staff Membership Development Strategy which has the following objectives:

- To create an engaged and supportive membership, representative of the public and stakeholders in our area.
- To inform members of the health landscape and provide them with the information to access services and make the best health choices.
- To enable members to influence the services the Trust offers them and hold the Board to account for the delivery of those services.
- To develop the infrastructure and processes to enable efficient and effective dialogue between the Trust Board and its members.

Our agenda is made up of items that are delegated by the Council of Governors, to which we are accountable, items for information and items on which we have required assurance.

The working group meets four times a year.

Monitoring Activity

The working group has reviewed and updated the Public & Staff Membership Development Strategy Objectives and Action Plan 2018-19.

Members provided feedback on the Urgent Care Centre tender at the North Wiltshire constituency meeting in April 2017. As well as the Constituency Meetings as a way of sourcing member feedback, in May 2017, the working group developed the "2017 Public and Staff Governor survey" which was disseminated to all members with the Notice of Election.

During the last election in May 2017, the membership team successfully increased the response rate of staff voting for their staff governors than in previous years.

In May 2017, the working group approved the "Staff Engagement and Departmental Sessions". This allows Staff Governors to attend departmental meetings and engagement sessions to better with staff and obtain their feedback on areas they would like brought to the attention of the Council of Governors and/or the Executive team .Staff Governors have attended six engagement sessions and sourced feedback which is presented at each Council of Governor meeting.

In May 2017, the Staff Governors attended a briefing with Associate Director of Organisation and People Development on embedding the values of the Trust and the outcomes of the staff survey. The working group developed the member engagement questions for the Annual Members Meeting which took place in September 2017. The working group have ensured that all of the feedback gathered at this meeting was analysed and used to inform developments across the Trust as appropriate. In addition within the quarterly editions of the Trust's Insight magazine, there is now a "You said, we did" style article to demonstrate how the Trust is acting on feedback from its members.

The working group approved the following topics to be covered in Insight RUH magazine:

- Staffing Changes (March 2018)
- How representative the membership is with regards to the service users (March)
- Update on the RNHRD & Therapies Centre (March)
- Discharge (June 2018)
- Car Parking (Sept 2018)
- Emergency Department (December 2018)



In August 2017, members of the working group worked with students from Wiltshire College in Chippenham to enable the students to gain experience of working to a 'client' brief and presenting their ideas, taking and acting on feedback to a project. The students enjoyed this experience and it is something the working group may consider undertaking again in the future.

Future work

Throughout the next year the group will continue to ensure that the public is at the heart of everything we do by engaging them in the development and transformation of their health services.
