Purpose

To provide the Council of Governors with an update following the Governor Membership & Outreach Working Group meeting held on 19th November 2018.

Background

The report is prepared to inform the Council of Governors on the salient issues discussed and agreed at the Governor Membership & Outreach Working Group.

Business Undertaken

The Working Group received the following updates:

- As at 8th November 2018 RUH Public Membership stood at 11,794 (an increase of 16 since the last report)
- The level of engagement of the membership and those recruited over the last quarter
- Analysis of the Membership and Engagement Strategy which included:
- Recruitment and engagement initiatives which would be taking place over the next 3 months.
